50 GEORGE III, CHAPTER 1, 1810 PROVIDED FOR THE APPOINTMENT OF "SURVEYORS OF HIGHWAYS" FOR EACH DISTRICT THEN EXISTING. THESE "SURVEYORS OF HIGHWAYS" WERE EMPOWERED TO LAY OUT ROADS, CLOSE ROADS AND DIRECT THE CONSTRUCTION OF ROADS. THE SURVEYOR'S REPORTS WERE SUBMITTED TO THE QUARTERLY MEETINGS OF THE APPOINTED JUSTICES OF THE PEACE FOR EACH DISTRICT.

THE JUSTICES WHO WERE THE JUDICIAL AND ADMINISTRATIVE AUTHORITY FOR THE DISTRICT APPROVED THESE REPORTS BY BYLAW AND THE ROADS SO LAID OUT AND APPROVED BECAME VESTED IN THE CROWN.

THESE ROADS REMAIN AS WELL ESTABLISHED AS IF LAID OUT BY CROWN SURVEY IN THE ORIGINAL SURVEY. THE ROADS CLOSED WERE TRANSFERRED TO PRIVATE OWNERSHIP IN A DEED ISSUED BY THE SURVEYOR OF HIGHWAYS UNDER AUTHORITY OF THE BYLAW OF THE JUSTICES.

THIS PROCEDURE FOR OPENING NEW ROADS CONTINUED UNTIL 1841 WHEN DISTRICT COUNCILS WERE SET UP AS THE ADMINISTRATIVE AUTHORITY BY THE MUNICIPAL ACT OF THAT DATE. THE DISTRICT COUNCIL HAD THE SAME AUTHORITY AS THE JUSTICES UNTIL THE MUNICIPAL ACT OF 1850.

THE CLERK FOR THE JUSTICES OF EACH DISTRICT WERE ORDERED BY THE ACT OF 1810 TO KEEP A RECORD OF ALL THE BYLAWS IN A BOOK.

DURING THE PERIOD FROM 1810 TO 1850 THE SETTLEMENT OF THE PROVINCE FORCED THE ESTABLISHMENT OF SMALLER DISTRICTS FROM THE LARGER ONES IN ORDER TO FACILITATE THE ADMINISTRATION. EACH NEW DISTRICT SO ONSTITUTED HAD ITS OWN JUSTICES AND CLERK AND A NEW SERIES OF BYLAWS BEGAN WITH EACH NEW DISTRICT. THUS IT IS POSSIBLE TO HAVE THREE OR MORE BYLAWS ALL BY THE SAME NUMBER IN ONE TOWNSHIP AND UNLESS THE DATE IS STATED, THE BYLAW CANNOT BE IDENTIFIED. WHEN LOOKING UP THE RECORDS OF THESE ROADS, IT IS NOT USUAL TO FIND THEM IN THE REGISTRY OFFICE.

THE RECORDS WERE SOMETIMES TURNED OVER BY THE CLERK OF THE JUSTICES OF THE PEACE TO THE DISTRICT CLERKS IN 1840 WHO IN TURN TRANSFERRED THEM TO THE COUNTY CLERK AT THE BEGINNING OF ADMINISTRATION UNDER THE MUNICIPAL ACT, 1850. SOME OF THE CLERKS OF THE PEACE RETAINED THE RECORDS WHICH ARE PROBABLY IN THE CROWN ATTORNEY'S RECORDS WHO IS ALSO THE PRESENT CLERK OF THE PEACE.

SOME OF THE ROADS CLOSED AND DEEDED BY THE SURVEYORS OF HIGHWAYS TO PRIVATE OWNERSHIP ARE FOUND IN THE REGISTRY OFFICE IN THE FORM OF MEMORIALS. THE NUMBER OF CONVEYANCES OF ROADS WHICH WERE REGISTERED ARE ONLY A SMALL PART OF THE NUMBER GIVEN IF THE RECORDS OF THE BYLAWS KNOWN TO EXIST WHICH CLOSE ROADS ARE AN INDICATION. THERE ARE PROBABLY MANY MILES OF ROAD ALLOWANCES OCCUPIED BY PRIVATE OWNERS WHOSE PREDECESSOR RECEIVED A PROPER DEED TO IT BUT BECAUSE OF NEGLECT OR THE NON-EXISTENCE OF THE REGISTRY OFFICE AT THE TIME HAVE NO RECORD OF THE TRANSFER.

RECORDS OF BYLAWS FOR ROADS PASSED BY THE SEVERAL DISTRICT COUNCILS ARE KNOWN TO EXIST AND ARE AVAILABLE AS NOTED ON THE FOLLOWING PAGES.
